India is the seventh largest country by area, the second most populous country with over 1.2 billion people, and the most populous democracy in the world.

Home to the ancient Indus Valley Civilisation and a region of historic trade routes and vast empires, the Indian sub-continent was identified with its commercial and cultural wealth for much of its long history.

India is a multilingual, and multiethnic society. It is also home to a diversity of wildlife in a variety of protected habitats.





Kerala, the 'God's own country', has nearly 600km of Arabian Sea shoreline. It's known for its palm-lined beaches and backwaters, a network of canals. Inland are the Western Ghats, mountains whose slopes support rubber, tea, coffee and spice plantations as well as wildlife. National parks like Eravikulam and Periyar, plus Wayanad and other sanctuaries, are home to elephants, langur monkeys and tigers.

Kochi is a city in southwest India's coastal line, in Kerala State. It has been a port since 1341, when a flood carved out its harbor and opened it to Arab, Chinese and European merchants. Sites reflecting those influences include Fort Kochi, a settlement with tiled colonial bungalows and diverse houses of worship. Cantilevered Chinese fishing nets, typical of Kochi, have been in use for centuries.
